## AGENCY UPDATES:

#### Teton Valley Health (TVH)

- 1. A second positive case of COVID-19 is confirmed in the Valley. It was **not** caused by community acquired infection.
- 2. We continue to offer a nurse phone line (208) 354-2383 for individuals with questions about testing.
- 3. Our Driggs clinic will be open regular hours (9-1) on both Saturday and Sunday.

#### **Drug Stores:**

- Corner Drug (Driggs): Curbside service only from 9:30am to 5:30 pm Monday thru Friday, Closed Saturday. Credit Card phone payments only to reduce interaction. Curbside service will be on the north or west side of the building. Please call 208-354-2334 to place orders, make payments and also to let us know when you are outside and we will bring it out to you.
- Victor Drug: will be open for drive-thru service only 9:30am-6:30pm Monday -Friday and Saturday 9am-5pm. Both locations will remain closed Sunday Use our free RefillRX app to request refills. Please send to the right location for better service. All the info you need is on your label to register with the app

## Teton County

- 1. The Board of County Commissioners met today and passed a resolution in an effort to protect the health and welfare of Teton County by reducing the spread of COVID-19.
  - a. Closed to the general public: all theaters, bars, self-serve buffets/salad bars and unpackaged food, communal pools, hot tubs, locker rooms, saunas, steam rooms, fitness centers, gyms, conference rooms, spas and museums.
  - b. Dine in service is closed but take out and drive through food service is allowed.
  - c. Gatherings of 10 unrelated people are strongly discouraged. <u>The full resolution can be viewed here</u>.
- 2. Teton County Facilities have been closed to the general public with the exception to the Courts and the Transfer station. The Transfer station is only taking payment by credit cards and accounts only and is no longer accepting cash. All other County business should be conducted on line, by phone or by mail.

#### City of Driggs:

- The City Council has extended the Emergency Declaration of the Mayor to require the following. <u>See full text</u> <u>here</u>. *These regulations will be strictly enforced*:
  - a. No gatherings of 10 or more unrelated people in the City of Driggs, including in any business, or other meeting place;
  - b. <u>Restaurants in the City are required to close their dining rooms, and may only offer curbside take-out, *no patrons allowed in restaurants* (even waiting for food.)</u>
  - c. No unpackaged self-serve food or beverages allowed;
  - d. Additional requirements apply, so see <u>Driggs City website</u> for more information.
  - e. Exemptions for Hospital and Health Care, Government Meetings, Grocery Stores (adhere to c.) and School Food Distribution apply.
- 2. City Offices remain open by appointment only. (Please call ahead to schedule, or use online methods.) All public meetings have been continued (postponed) until we can set up safe and functional remote meeting options.

- 3. All group events at Driggs Community Center have been cancelled or postponed, but the building remains open during business hours. TISA, Seniors, Rock Gym, and GeoCenter have all closed or limited access to their facilities. Please contact them directly if you have any questions.
- 4. Driggs Reed Memorial Airport remains open for aviation access only at this time.
- 5. Driggs City Parks remain open per normal hours. We encourage people to get outside, and move their bodies just avoid groups. Be advised that, although our restrooms are being cleaned, playgrounds are not receiving any special attention at this time.
- 6. The City would like to emphasize that city water remains completely safe. There is no possibility of contamination of the city water supply.
- 7. Please do not flush anything down toilets except toilet paper!

#### **City of Victor:**

1. On March 18, 2020, Chair Riegel, Mayor Frohlich, Mayor Johnson, and Mayor Hoopes signed a Joint Emergency Declaration for Teton County, Idaho and the Cities of Tetonia, Driggs, and Victor. The Victor City Council subsequently extended the declaration through April 30, 2020 on behalf of the Victor community.

In our state, this effort is being led by the Idaho Department of Commerce.
