### **Positive COVID-19 Test Results**

Case #36: We are reporting a positive COVID-19 test result for a female in her 60s in Teton County. This individual was not hospitalized and is recovering at home. Community transmission of COVID-19 is identified as the source of exposure. This is the only case remaining in Teton County that is being monitored. All other cases in Teton County have been released meaning they may not be fully recovered but are no longer contagious and have been released from all isolation restrictions.

### **TETON VALLEY HEALTH (TVH)**

TVH has received rapid testing equipment and it is now operational. More testing is now available for symptomatic patients. Please contact our COVID nurse at 208-354-2383 for further information and prior to going to the hospital. TVH would also like to assure the public that currently there is capacity to deal with all health issues and to not hesitate to call the nurse's line or to schedule an appointment for care. As always, if you are in a life threatening emergency please dial 911.

#### **COUNTY AND CITIES**

The Board of County Commissioners and the cities of Driggs, Tetonia, and Victor have measures in place that are consistent with the amended governor's Stay-Home Order. Any facility or service (including formerly "non-essential" businesses) can begin to operate via curbside services, drive-in, drive-through pickup, mailed services or delivery services.

Businesses that must remain closed are: indoor gyms, recreational facilities, nightclubs, bars, entertainment venues, convention centers, hair and nail salons, public events and gatherings, dine-in restaurants (drive-thru, carry-out, delivery to continue), and other facilities and services not included in "essential" businesses as defined in the order.

The Board of County Commissioners is meeting on Monday April 20 at 9:00 am to discuss the status of the COVID-19 Building Policies and their effect on construction thus far. The meeting will be livestreamed at www.tetoncountyidaho.gov.

#### **TETON SCHOOL DISTRICT 401**

The State Board of Education met on Thursday April 16 to determine criteria that would have to be met to allow school districts to open up if desired. The Board of Trustees of Teton School District has a special meeting for Monday (April 20) at 5:30 pm to discuss the Governor's amended stay-at-home order of Wednesday (April 15) and the decision of the Board of Education. The TSD 401 School Board meeting will be held remotely and live-streamed on the district's Facebook page. Public comment will be accepted prior to the meeting. The school district is still providing free meals to those aged 1-18. To date, the total of meals served is 14,305 -- nearly 600 per day. Families are asked to please signup, for the week ahead, or by midnight the night before meal pickup, at the Home-Based Learning Portal on the district website, <u>tsd401.org</u>.

Those who have experienced a change in income due to the COVID-19 pandemic are encouraged to apply for Free or Reduced lunch. It's important for the district to have accurate data regarding people's current needs. That application, in both English and Spanish, is also available on the district's website, under the Parents/Students tab; there, go to "School Lunch Details" and scroll to the bottom.

### RECREATION RECOMMENDATIONS

Though the Governor's stay home order has been extended, it doesn't mean people are discouraged from getting outside for recreational opportunities, in fact we are encouraged to do so. Being active is one way to keep our bodies and minds healthy through this difficult time. However, it is very important to maintain social distancing recommendations while using trails, rivers, boat ramps, and local parks in order to slow the spread of COVID-19. Please recreate while maintaining a six foot distance between anyone not living in your household.
