Chief Maltaverne reported that Jackson Fire & Ems have hired both a new Fire Chief and a new Fire Marshall. He will be meeting with the new Chief in the following weeks. Chief Maltaverne attended a Training at Grant Targhee to better serve the community. Chief Maltaverne has been working with the County on creating an Active Response Plan for a shooting. Chief Hoyle reported that the water tender sold for \$22,000.00. The lettering project has been done on all the engines. Mariana O'Neill presented the FY 2022-year end report.
