Meeting began @ 1600 hours

Minutes: Commissioner Letham asked if there were question or comments on the prepared minutes from

the September 13 and August 23, 2022 meeting.

No questions or comments were made.

Commissioner Letham made a motion to approve the minutes as presented.

Commissioner Borbet seconded the motion.

Commissioner Letham asked for all in favor. All replied "aye", and the minutes were approved.

Budget Statement:

Open Sealed Bids for Semi Tractor Sale:

All bids were noted and Secretary O'Neill presented the highest bid. Per ID Code 67-2806, the governing Board must select and approve the highest bid. The highest bid came at \$46,100.

Commissioner Letham made a motion to sell the item to the highest bidder at \$46,100. Commissioner Borbet seconded the motion.
