# EASTERN IDAHO PUBLIC HEALTH (EIPH) (from daily reports April 11 - April 13)

Case # 32: We are reporting a positive COVID-19 test result in a female in her 30s who lives in Bonneville County. She had contact with a confirmed case of COVID-19. She was not hospitalized and is recovering at home while self-isolating.

Case # 33: We are reporting a positive COVID-19 test result in a male in his 50s who lives in Bonneville County. He was not hospitalized and is recovering at home while self-isolating. Community transmission is identified as the source of exposure to the virus.

The Stay at Home order announced by Governor Brad Little on Wednesday, March 25, 2020 is set to expire at 11:59 p.m. on Wednesday, April 15, 2020. Governor Little is planning a press conference on Wednesday, April 15 at 11:00 a.m. to announce the plans for the State moving forward.

# **TETON VALLEY HEALTH (TVH)**

TVH has new rapid testing equipment in house. They have developed a validation protocol with the state to ensure that the machine is testing accurately and will run that validation Tuesday or Wednesday. They are working with epidemiologists to develop a sampling mechanism to best determine how prevalent COVID - 19 is in our valley and hope to begin testing this week.

Having rapid testing equipment will allow health officials to better assess the health status of our community as related to COVID-19. With community spread and limited testing, it has been difficult to determine the true impact of COVID - 19 on our residents thus far. Having more accurate numbers will aid in response efforts and will assist in predicting the future implications of the pandemic on our community.

Additional data for Idaho: there have been 135 hospitalizations across the state and a total of 15,114 people have been tested for COVID-19.

### **VISITORS AND RENTALS RESTRICTIONS**

The City of Victor passed two emergency ordinances on April 8, 2020 providing <u>self-quarantine requirements</u> for visitors and limiting <u>short term rentals</u> through May 31, 2020.

Today, the Board of County Commissioners passed a resolution that places restrictions on visitors coming into Teton County by encouraging self quarantine measures for 14 days upon arrival.

"...Any person coming into Teton County to reside permanently or temporarily should self-quarantine for a period of fourteen days from the date of arrival. During a period of self-quarantine, a person in self-quarantine should remain at a residence and should not enter any business or public recreation area nor have contact with any other person except a household member who is also in self-quarantine. Persons traveling through Teton County (including those in recreational vehicles) should avoid stopping at any public recreation area, business or residence except as required to perform Essential Activities, operate Essential Businesses, or maintain Essential Governmental Function".

In the same resolution restrictions were placed on lodging within the county.

"...Each Lodging Facility in Teton County should stop renting rooms or residences to any person who is not a resident of Teton County, a Healthcare Operations employee, or a government employee performing Essential Government Functions. The terms Healthcare Operations and Essential Government Functions are defined in the IDHW Order..." read full resolution here.

The resolution is in effect until May 31, 2020 unless terminated prior to that by the Board of County Commissioners.
